Variety of Kansas City was able to provide services in two major areas, community projects and mobility & communication. Variety of Kansas City provides funding for community projects to provide access and inclusivity for children with disabilities. A few examples from the 21-22 fiscal year include a splash pad in the City of Lathrop, changing stations and sensory kits for The KC Royals, and accessibility at the KC Zoo. VKC was able to distribute \$215,197.29 in community projects within the KC area. VKC also provides mobility and communication devices for children. In FY 21 - 22, VKC provided \$298,418.68 for the purchase of 227 devices to over 100 children with disabilities. These devices included a modified van, adaptive bikes, computer equipment and apps, and modifications to current equipment.
